

HAWAII COATING LLC COIL GUARD STANDARD WARRANTY

WHAT IS THE HAWAII COATING COIL GUARD CONDITIONAL WARRANTY?

HAWAIICOATING warrants that HAWAIICOATING Coil Guard when applied in its correct form and following all of the application and maintenance procedures will withstand exposure to the chemicals and elements at concentrations as listed in its resistance list for a minimum of three (3) years from the date of application.

HAWAIICOATING warrants that if any defects are found and can be attributed to a Coil Guard defect, defect in the recommended application procedure or defect in the recommended maintenance procedure or any other defect that is in the direct control of HAWAIICOATING LLC., then the coil coating will be repaired or replaced at no cost to the end user or customer, providing that the terms of the warranty document are met with regards to registration, location and access.

COIL GUARD STANDARD LIMITED WARRANTY

HAWAIICOATING Coil Guard is resistant to various agents and particles and have been tested in laboratory conditions. This limited warranty is based on the results of these tests.

Resistance is expressed in terms of vapors and not fluids. Values are based on average vaporized concentrations during the period of the warranty. Exposure to fluids, cleaning agents, chemicals not listed, process fluids or any other substance not specifically stated are not covered under this warranty without the prior express written consent of HAWAIICOATING LLC.

Full resistance list is available from any authorized HAWAIICOATING distributor

SCOPE

Subject to the terms and conditions, limitations and exclusions of this warranty, the HAWAIICOATING Coil Guard system will be free of defects for the period of three years, if used only for purposes approved by HAWAIICOATING. HAWAIICOATING warrants, that the materials herein are meeting HAWAIICOATING product specifications.

Under this Warranty, HAWAIICOATING will repair, at no cost, all HAWAIICOATING Coil Guard coatings found to be defective within three (3) years from delivery month mentioned on the HAWAIICOATING sticker. It is the specific responsibility of the user of the installation to notify HAWAIICOATING, and request, prior to installation, the terms as described hereunder. It is the specific responsibility of the customer not to accept a HAWAIICOATING treatment without a warranty sticker. If no sticker is present the warranty will be void.

Warranty conditions in other exposure conditions (HAWAIICOATING resistance list), or to other heat exchangers than copper tubed aluminum finned condensers are only valid if approved by HAWAIICOATING in writing. This may concern different project specifications or other heat exchangers than Copper Aluminum Condensing Coils.

In PACIFIC exposure conditions monthly maintenance according to the maintenance conditions described in the according document is required to maintain the warranty terms. It is the specific duty of the customer to maintain a maintenance administration and to request the maintenance procedures by HAWAIICOATING

TERMS AND CONDITIONS

This warranty is only valid for installations within the USA. No warranties outside the USA are provided for in this warranty. Other warranties are available by contacting HAWAIICOATING Inc. and requesting terms and conditions of specific regions.

This warranty is provided by *HAWAIICOATING LLC*., who is solely responsible for it. This warranty states that *HAWAIICOATING LLC*., will reapply or repair any HAWAIICOATING Coil Guard coating found to be defective in its stated duties within three (3) years from its application date as listed on the duly completed and recorded "Warranty Registration report"

HAWAIICOATING Inc. will determine the action to be taken and may, at its own discretion, have this work performed by any authorized HAWAIICOATING distributor.

It is the responsibility of the purchaser of any HAWAIICOATING product to obtain a copy of these warranty terms and conditions.

This warranty is only valid if/to:

- HAWAIICOATING Coil Guard coating on the heat exchanging surface constructed of aluminum fins over copper or aluminum tubing.
- HAWAIICOATING has applied the coating. The application of the HAWAIICOATING product has been done in accordance with
 the set protocols as specified by HAWAIICOATING LLC., and carried out by an authorized, trained and certified
 HAWAIICOATING distributor.
- Information provided at the sole discretion of HAWAIICOATING concerning the exposure conditions is accurate and complete. The
 exposure conditions do not exceed the maximum accepted concentration values as listed chemicals in the resistance list for the
 particular product used.
- The exposure conditions do not exceed the maximum accepted concentration values as listed chemicals in the resistance list for the particular product used.
- 5. For all maintenance activities mild detergents only are used.
- 6. Inspections and maintenance have been performed as per the requirements for the particular product. It is the responsibility of the purchaser of any HAWAIICOATING product to familiarize themselves with these requirements. These can be found on the web site.
- 7. Regular inspection / maintenance conditions meet the HAWAIICOATING specifications. If during the three years any pressure drop or capacity problem occurs due to pollution of the coil, the cleaning activity by HAWAIICOATING will be charged at the regular market prices as it is considered to be non-regular maintenance. This maintenance must be executed by HAWAIICOATING otherwise the warranty will be void.
- 8. The owner gives notice of failure of the HAWAIICOATING material to HAWAIICOATING in writing seven (7) days after discovery of the failure. An inspection of the coils is required each month. After providing such notice, customer shall allow HAWAIICOATING Applicator or its representative free access to the installation site for inspection and sampling of fin material or air sampling and taking pictures of the damage, at their earliest convenience. If notice is not given within such seven (7) day period, any claim for breach of this warranty shall be conclusively deemed to have been waived, and HAWAIICOATING shall have NO LIABILITY under this Warranty.
- 9. In the event of a coil coating failure, a sample of the damaged coil will be taken to resolve any dispute. An independent laboratory will conduct tests. The independent analyses do not conclude exceeded concentrations of particles listed in the resistance list. The warranty holder accepts the conclusion of this report unconditionally and consequently the possible denial of the warranty claim. HAWAIICOATING will charge the costs of the analyses and coil inspection to the warranty holder. HAWAIICOATING has the right to appoint an independent laboratory at its sole discretion.
- 10. The warranty claim will not change the expiration date of the warranty.
- HAWAIICOATING warranty sticker is attached. The warranty shall be voided if the HAWAIICOATING sticker/tag has been removed, destroyed or rendered ineligible.
- The HAWAIICOATING warranty registration document has been duly completed and logged with HAWAIICOATING LLC. and a
 warranty registration number has been issued.
- 13. Any service performed during this warranty period will not extend the warranty beyond its original 3 year period from the application date listed on the warranty registration form.
- 14. Coils damaged in transit or during installation must be brought to the immediate attention of the HAWAIICOATING Licensee. At such time the coating will be repaired at the cost of the customer. Failure to repair any damage to the coil will result in the warranty being voided.

These warranty terms are automatically accepted by the customer at sending the purchase order.

LIMITATIONS

Damage : Typically if more than 5% of the HAWAIICOATING protective coating has worked loose as a result of demonstrable material defects or application errors and this has lead to corrosion of the treated surface. In no way whatsoever HAWAIICOATING will be responsible for any consequential or inconsequential damages due to the failure of its product.

Coverage: In event of a claim, the covered costs of rectifying the defect will be for the sole discretion of HAWAIICOATING, but limited to:

- Inspection of the damage.
- Renovation of the HAWAIICOATING coating system.

Any waiting hours, or other costs not related to the direct execution of the warranty job will be charged for at the warranty holder. HAWAIICOATING is not liable for any restrictions following the regulations at the installation site, transport from main local (air) port to the site.

THE ABOVE LIMITED WARRANTY TERMS SHALL BE IN LIEU OF ANY AND/OR ALL OTHER WARRANTIES, AND ALL OTHER SUCH WARRANTIES ARE EXPRESSLY DISCLAIMED OR DENIED. IN NO EVENT SHALL THE HAWAIICOATING LICENSEE BE LIABLE TO YOU OR YOUR CUSTOMERS FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES, LOSS OF PROFITS (ANTICIPATED OR ACTUAL) OR ANY OTHER ECONOMIC LOSS ARISING FOR ANY REASON. THIS WARRANTY IS FOR YOUR BENEFIT ONLY AND SHALL NOT BE TRANSFERRABLE TO ANY OTHER PARTY.

EXCLUSIONS

This Warranty excludes any events including but not limited to (a) physical damage or abrasion to the Heat Exchanging System caused by animals, flying or falling objects, or natural disasters including but not limited to earthquakes, hailstorms, windstorms, hurricanes, and tornadoes, (b) vandalism, (c) structural movements, (d) defects in the construction of the heat exchanging machine (e) direct contact with hydro-carbons, or any other chemical (solid, liquid, gas, or any other form) that is not listed or that has not been otherwise approved by HAWAIICOATING in writing, or (f) non regular cleaning by a non-authorized party, without any prior written consent by HAWAIICOATING or (h) damages have occurred during transport to the site or installation (i) damage following serious negligence of the owner (j) all follow up damages to company processes or fines or claims of third parties, (k) damages following poor maintenance or non compliance to maintenance guide lines (l) damages to coils or parts which are not clearly defined under this warranty (m) any other damages to company processes, employees or assets.

Notwithstanding any other provisions of this Warranty, this Warranty shall not become effective until HAWAIICOATING has been paid in full for all materials and services.

GENERAL

This Warranty is provided only to the original register of the warranty certificate at the original location of the equipment and cannot be transferred in name or location without the explicit written consent of HAWAIICOATING LLC.



There are no other remedies or warranties, expressed or implied, including but not limited to the warranties of merchantability and fitness for a particular purpose. HAWAIICOATING LLC. and its authorized distributors shall have no liability for any injury, loss or damage (direct, indirect, consequential or however characterized) arising out of the HAWAIICOATING products, its application or use, regardless or whether or not the possibility of or the existence of such injury, loss or damage has been communicated to HAWAIICOATING LLC. or its authorized distributors.

Notice: This warranty gives you specific legal rights and you may have other rights, which vary from state to state. There are no warranties applicable to HAWAIICOATING products except as expressly stated herein or as required by applicable state and federal law. HAWAIICOATING Inc. and its authorized distributors will not be responsible for any statements or representations made in any form that go beyond, or are broader than or are inconsistent with this warranty.

INSPECTION & MAINTENANCE REQUIREMENTS

The following are the inspection and maintenance protocols required as part of the terms and conditions of this warranty.

- The coil should be cleaned and inspected monthly to ensure maximum efficiency of the coil and coating commencing immediately
 after installation. A monthly maintenance log should be maintained for warranty purposes.
- 2. The coated coils should be inspected for any damage which may have occurred during transit immediately following installation.
- 3. The coil should be rinsed with clean, fresh water and washed with a solution of HAWAIICOATING Coil Cleaner (a pH neutral cleaner) and water and rinsed thoroughly with clean fresh water using a low-pressure sprayer. This is recommended to be completed throughout the life of the unit to improve operating efficiency and also to maintain and enhance corrosion resistance capability.
- After each wash, the coil should be inspected for any damage, onset of corrosion or deterioration of the coating. Any damage or corrosion noticed during inspection should be logged and an HAWAIICOATING representative notified.
